Purpose:

The purpose of this policy is to establish fees and charges for various municipal services, activities or licenses to assist in reimbursing the municipality for administrative, legal, filing and other associated costs.

Fees and charges will be established below and invoiced according to this policy.

Tax Certificate	\$25.00 (will be stated in Tax Levy By-law)
Tax Sale Costs	actual costs
Tax Sale Agreement Fee	\$100.00
Assessment Appeal Fee (Class 60T – Commercial/Industrial)	
Application Filing Fee (Minimum)	** \$50.00 per roll number
Application Filing Fee (Maximum)	** \$500.00 per roll number

** Fee is \$10 per \$100,000 of property assessed value that is the subject of appeal, as determined by the Provincial Assessment Branch, subject to a minimum fee of \$50.00 and a maximum of \$500.00.

** Filing fees are non-refundable (including withdrawals).

Beaver Bounty	\$100.00 each
<i>(If there is a drainage concern caused by a nuisance beaver, the Councillor of the area MUST approve the request PRIOR to the removal of the beaver in order for the fee to be paid.)</i>

Trailer License Fees (Value Based)

Square Feet of the Trailer (and additions) X Market Value Rate X Portioning Rate for Residential
Less Depreciated Value

= Net amount for taxation X Current Year's residential tax rate

= License Fee Example:

a 1995 Trailer that is 1,500 square feet based on 2017's rates:

1500 x \$70 x 45% = 47,250.00

49% x 47,250 = -23,152.50

Amount to apply tax rate 24,097.50

License Fee = \$24,097.50 x 23.72 mills = \$571.59 (calculation is based on the 2017 mill rate.)
